- 2) Any branding or signature by the carver must be limited to the underside of the decoy as to not be visible when afloat in the upright position. To assure anonymity of the carver, any identification on the decoy will be masked prior to judging, if necessary.
- 3) "Best of Show" winners receive a purchase award, plaque, and recognition at the banquet.
